Forms Needed For a Chapter 7 Filing. In addition to filing the Voluntary Petition form, Chapter 7 consumer debtors need to file the following supporting documents. Your local bankruptcy attorney will explain the time requirements, and what each document means in more detail but this is a general list of the forms you can refer to once you've decided to go the route of a chapter 7 bankruptcy.

7. File the forms. Filing your petition (the main bankruptcy form, schedules, and other forms) officially starts your case. Most people file all the forms at once, but if you're pressed for time, you can opt for an emergency filing by completing a few required forms. You must file the remaining forms within 14 days.

“You must file 22A-1, the Chapter 7 Statement of Your Current Monthly Income (Official Form 22A-1) if you are an individual filing for bankruptcy under chapter 7. This form will determine your current monthly income and compare whether your income is more than the median income for households of the same size in your state.

U. Statement of Intention for Individuals Filing Under Chapter 7 (Official Form 108) - this form must be filed within 30 days from filing of the bankruptcy case or by the date set for the meeting of creditors [11 U.S.C. § 521(a)(2)(A)].

Chapter 7 Petition Package (Individual Debtors)

In order to file Chapter 7, you must fill out schedules A through J. You also need to fill out the Summary of Schedules, which is a summary of schedules A through J. You must fill out additional forms as well, including the Statement of Financial Affairs, a Statement of Intentions, and the Means Test.

To be eligible to file a Chapter 7 bankruptcy, you must first qualify. The “means test” calculates whether you have the “means” to pay back a portion of what you owe to your creditors. The purpose of the means test is to disqualify people with high incomes from wiping out debt by filing for Chapter 7 bankruptcy .
