FHA Appraisal Requirements for Swimming Pools. In a section entitled "Appraiser and Property Requirements," the FHA handbook states: The Appraiser is required to report any "readily observable defects" that might render a swimming pool inoperable or unusable.

Swimming Pools Swimming pools are permitted under current FHA property requirements, but the Mortgagee / lender must ensure that the pool complies with all local safety laws and ordinances. For instance, in some cities swimming pools are required to have a safety barrier of some kind.

If you're refinancing your mortgage or purchasing a new home, and the property has an inground pool, the appraiser will need to inspect the pool to make sure it meets FHA's criteria for pools. Our regulations state that appraisers will need to report any defects (that are readily observable) in a pool that is uncovered if those defects make the pool inoperable or unusable.

By contrast, swimming pool rules that banned children under the age of 5 from the pool, and that limited pool use to 11 a.m. to 2 p.m. for children between 5 and 16 were found to be in violation of the FHA as too restrictive and/or not tailored to real safety considerations. Another common target of the FHA is "adult swim" periods.

Swimming Pools - Swimming pools must comply with all local ordinances (perimeter fencing, covers, etc.). Swimming pools must be operational to provide Contributory Value. The appraiser must report readily observable defects in a non-covered pool that would render the pool inoperable or unusable. If the pool water contains algae and is aesthetically unappealing, but not otherwise contaminated, no cleaning is required.

FHA guidance maintains that the more it appears that a pool is available for the public's use, the more likely ADA rules will apply. Also under the FHA, apartment management must not discriminate against a disabled resident in the use of a given community's amenities.

No comparable sales with a pool means that it is too unique and lenders shy away from unique. In addition, if a pool is not in working order, it cannot be considered and included in appraised value. A swimming pools FHA inspector will have a list of standards with which the home's pool must comply before closing on the sale can be scheduled. For a pool to contribute value, it must be operational. When a pool has algae or looks unappealing, but there is no proof of contamination, cleaning is not required. ...

Take for example a rule that states "no animals are permitted in the pool facility". To comply with the FHA, an exception would have to be made for assistance animals on the pool deck (although the animal could still be prohibited from entering the water due to health and safety concerns).

Swimming Around Pool Rules in Community Associations. A community associations pools typically have prominently displayed pool rules. Beyond the typical "no diving" or "no glass container" rules, we also often see rules prohibiting children under the eighteen (18) from swimming without an adult supervision. Although these rules may have been enacted from a risk management standpoint, they must also be considered against the framework of the Fair Housing Act.
